## 4 Direct Debit Agreement

By returning the above form I/we request Mullum Mullum Indigenous Gathering Place (MMIGP) to arrange for funds to be debited from my/our account at the financial institution identified on the enclosed form and as prescribed through the Bulk Electronic Clearing System.

4. We require 14 days' notice of request to cancel or alter your debit agreement.
